



SERVICE AGREEMENT

**THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS.
PLEASE READ CAREFULLY AND SIGN.**

This is an AGREEMENT between PERFECT PETS, LLC., doing business as “BUCK’S KENNELS” and the Owner whose name is _____ and whose signature appears at the end of the document (hereinafter called “Owner”). The following are the terms of service for the stay of the Owner’s pet

as a lodging stay guest or fitness club member at BUCK’S KENNELS. By signing below, in consideration of the services rendered by BUCK’S KENNELS to the pet(s), Owner acknowledges reading, understanding, and accepting the statements herein.

Owner: I represent that I am the owner of my pet and I am fully authorized to enter this agreement.

REFUSAL OF SERVICE

I understand BUCK'S KENNELS reserves the right to deny admittance to any pet for any reason, at any time.

PET REQUIREMENTS

I request that my pet meet all the following requirements:

- It is current on their required vaccinations.
- It is on a monthly flea and tick preventative medication.
- Have been in good health for the last 30 days before check-in.
- My pet is not aggressive, nor has it shown signs of aggression to other dogs or humans.
- I have completed the Owner/Guest Profile and read the Buck's Kennels Guidelines.
- My dog will enter and exit BUCK'S KENNELS on a non-retractable leash

"In heat," dogs will NOT be allowed in the Daycare group play. Daycare: must be spayed/neutered after 6 months of age.

VETERINARIAN LIABILITY AND CARE

If the pet is ill or injured while participating in activities at BUCK'S KENNELS, we will make every reasonable effort to reach the owner in accordance with the emergency contact information provided to BUCK'S KENNELS. However, if BUCK'S KENNELS is unable to reach the Owner, the Owner grants consent to BUCK'S KENNELS to seek appropriate veterinary care, and the Owner accepts responsibility for any and all associated expenses. BUCK'S KENNELS will not pay any portion of veterinary expenses associated with seeking medical care for the pet if necessary. Medical treatment may require transportation of my pet to receive care, and I hereby authorize such transportation.

FLEAS AND TICKS/SEASONAL

I agree that if any fleas or ticks are discovered on my pet during check-in or at any other time while my pet is receiving services at BUCK'S KENNELS, will be required to pick up my pet. If a flea preventative medicine, Capstar, and a bath are administered, it will be at the owner's expense.

CONTAGIOUS DISEASES

Owner specifically represents BUCK'S KENNELS that, to the owner's knowledge, the pet has not been exposed to any contagious diseases within the 30 days before check-in. Owner

understands that each time the pet is brought to BUCK'S KENNELS, Owner is recertifying that the pet is in good health and has not had any communicable illness of any kind for 30 days before check-in.

DAYCARE

I understand that BUCK'S KENNELS has off-leash playgroups where multiple dogs will interact. I understand that dogs often play with their mouths and paws, which can result in nicks and scratches on pets. While BUCK'S KENNELS provides reasonable care, trained professionals, and 100% supervision in the playgroups, I understand and agree that it's possible BUCK'S KENNELS employees may not notice these nicks or scratches before my pet's departure, and, therefore, I might not be notified.

SERVICE FEES

I agree to pay for all fees, services, and products with a credit card, cash, or check at the time of my pet's pickup from each visit. I furthermore agree to pay for any additional services requested during the pet's extended stay at BUCK'S KENNELS.

PHOTO AND VIDEO RELEASE

I agree to allow BUCK'S KENNELS to use my pet's name and any images or videos taken while they are in the care of BUCK'S KENNELS, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade, or promotional materials.

AGREEMENT TO PARTICIPATE AND LIABILITY WAIVER

Owner understands certain activities that the pet may participate in, including Daycare, Grooming, Boarding, one-on-one play, movement within and outside the facility, involve risk and possible injury, including but not limited to: exposure to parasites, viruses, and other medical conditions passed from dog-to-dog or person-to-dog; sprains, strains, bites, broken bones, fatigue, dehydration, nicks, cuts and loss of dog or death.

Owner further understands that not each and every potential risk can be listed above, but nonetheless, agree that the benefits associated with dog socialization outweigh the possible risks, therefore, Owner hereby voluntarily releases, forever discharges and agrees to hold harmless and indemnify PERFECT PETS, LLC, DBA BUCK'S KENNELS, ITS OWNERS, EMPLOYEES AND AGENTS from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with the dog's participation in activities at BUCK'S KENNELS, including those allegedly attributable to the negligent acts or omissions of BUCK'S KENNELS or their staff. Further, Owner understands that Owner may be exposed to certain risks when bringing the dog to participate in activities at BUCK'S KENNELS or

When picking up the dog from participating in activities at BUCK'S KENNELS. Such risks may include property damage and/or physical injury inside or outside the building, such as from falling, slipping, illness, and/or dog bites.
